## *Executive Summary*

Leslye Obiora served as the Minister of Mines and Steel Development for the Federal Republic of Nigeria and is currently a Professor of Law at the University of Arizona. Her rich multi-sector experience has earned her distinguished honors and awards. She was the Coca Cola World Fund Visiting Faculty at Yale University and the recipient of prestigious fellowships from the Institute for Advanced Study at Princeton, Center for Advanced Study in the Behavioral Sciences at Stanford, Rockefeller Foundation Bellagio Study Center, and the Djerassi Resident Artist Program. A member of the Council on Foreign Relations, she was a former Manager of the World Bank Gender and Law Program, the Genest Global Faculty at York University in Toronto, and the Visiting Gladstein Human Rights Professor at the University of Connecticut. She is on the Board of Directors for the Management Sciences for Health and for UniversalGiving. She has been a Trustee of the Association of Members of the Institute for Advanced Study and a two-time member of the Law and Society Association Board. Dr. Obiora has also served on the boards of the YWCA of Southern Arizona, Tucson Art Museum, and Casa de los Niños, among others. Her scholarship has contributed to critical interdisciplinary knowledge production and creative public policy.

Building upon the pragmatic lessons learned from high-stakes decision-making, Dr. Obiora has crafted an academic career anchored on an ethic of service. Thus, she complements research, scholarship, and teaching with an acumen for impactful outreaches and engagements dedicated to bolstering meaningful capacity to solve pressing problems facing society. For instance, she played a pioneering role in stimulating the growth of indigenous philanthropy in Nigeria which helped to catalyze the inauguration of the Africa Philanthropy Forum by the Global Philanthropy Forum.
